The National Agency of the Mine Patrimony (**ANPM**) is launching a national and international call for bidding on the four (04) mining sites mentioned hereunder for **PROSPECTING** :

Bidders interested in the call for bidding may withdraw the tender document for each site as of **december 2nd, 2007** from The National Agency of the Mine Patrimony (**ANPM**) located in Algiers, Val d'Hydra Tour B against the payment of an amount of :

- ✓ 300 US\$ for foreign companies, payable by payment to ANPM Account nr **609.310.100.069-39** at the Banque Nationale d'Algerie (BNA) 119, rue Didouche Mourad Alger.

- ✓ The same amount converted into Algerian Dinars based on the exchange rate of the day for Algerian registered companies, by payment to ANPM Account nr **609.200.013.110-69** at the Banque Nationale d'Algerie (BNA) 119, rue Didouche Mourad Alger.
